ECFS membership

The ECFS is asking that every member of a Special interest Group should be an ECFS member. You may have already received an email from the ECFS about this. The ECFS conference is partly funded through membership fees, which are essential for maintaining independence.

ECFS membership is valid for a calendar year, from January to December. For nurses and allied health professionals, the fee is 50€ (instead of 120 €). Benefits include reduced registration costs for next year's conference, full access to educational material, and "members only" information on "MyECFS". Members also receive periodic newsletters and have voting rights.

Innovation award (2024)

If you are interested, please submit your idea or project through the NSiG webpage link, which will be available starting on January 15th. The submission deadline is April 21st, 2024. The NSiG committee will review all proposals and reach out to applicants in early May.

Your proposal should include the following information:

- What is the innovation? e.g.: change in the care pathway during paediatric to adult transition; nurse follow-up after Trikafta introduction; developing mental health support...
- O What is the goal of your project?
- What steps have you taken or do you plan to take, and how will you implement your idea?
- O How has patient care improved / how do you expect it to improve?
- What challenges have you encountered and how have you addressed them?
